



## 2022-2023 Boston Public School District Fall Grant Program

Universal Technical Institute/NASCAR Technical Institute  
Motorcycle Mechanics Institute/Marine Mechanics Institute

Grant Amount: \$6,000

### Objective:

To provide tuition assistance to students who seek to enroll at Universal Technical Institute, Motorcycle Mechanics Institute, Marine Mechanics Institute, or NASCAR Technical Institute. This grant program is aimed at students who reflect a true commitment to converting their talents working with their hands into a career as a professional in the trades industry.

### Criteria for awarding the grant:

This grant program is available to all students who are currently enrolled and set to graduate, or who graduated from a Boston Public School District High School either during or after the 2020 academic year. All applicants must meet all other admissions requirements for Universal Technical Institute, in addition to all of the criteria outlined below, to be eligible to apply.

### Students must:

- Be enrolled to start UTI, MMI, or NASCAR Technical Institute
- Be able to show proof that they are currently enrolled and set to graduate, or previously graduated from a high school located within the Boston Public High School District during or after the 2020 academic year
- Provide the name, organization, and contact information of someone who can speak to your professional character
- Answer the essay questions listed in the application
- Must redeem grant and start classes at Universal Technical Institute, Motorcycle Mechanics Institute, Marine Mechanics Institute, or NASCAR Technical Institute by December 31, 2023

**Process and Rules:** This grant program is available starting October 1, 2022, through December 11, 2022. Students must complete an application and essay and submit both to the UTI Scholarship Department. For all applicants, the deadline for receipt of the application by the Scholarship Department is **Sunday, December 11, 2022**. All eligible applications will be reviewed by the UTI Scholarship Committee, and five (5) applicants will be awarded no later than **Monday, December 19, 2022**. **This grant is ONLY available to incoming students who attended high school in the Boston Public School District. Students already attending classes at UTI, MMI or NASCAR Technical Institute are ineligible to apply.**

### Application submission options:

- a) Scholarship Universe [www.uti.scholarshipuniverse.com](http://www.uti.scholarshipuniverse.com) – If you have not done so already, you will need to create an account with Scholarship Universe. This can easily be done using your UTI student email. Once your account has been created you will be prompted to start answering general questions that will automatically match you to scholarship programs that you are eligible to apply for.

Only one award of this grant will be given per student. Students who apply and meet all requirements will be considered for this grant. Of those viable applications, the awards will be distributed to those students who most clearly express commitment to success as a professional in the trades industry through the essay questions asked in the application. All viable applications will be reviewed by the UTI Scholarship Committee. Students must be enrolled to attend Universal Technical Institute, Motorcycle Mechanics Institute, Marine Mechanics Institute, or NASCAR Technical Institute at the time of application submission\*. Grants awarded are not transferable to any other person. This grant is considered an internal tuition reduction and has no cash value. All internal tuition reductions are pro-rated over the time a student is in school. If a student chooses not to attend UTI prior to the deadline or, after beginning their program chooses to leave for any reason (withdrawal, suspended, terminated), they will forfeit any unused portion of the award. All grants awarded through this program can only be used during the initial enrollment; any unutilized funds cannot be applied to a secondary account/enrollment.
