

UNIVERSAL TECHNICAL INSTITUTE - ORLANDO GRANT OPPORTUNITIES

ELIGIBLE DATES: VALID FOR JULY 1, 2023 – SEPTEMBER 30, 2023, START DATES

Unlike a loan, a grant does not have to be repaid. The Institutional Grant and Relocation Grant are designed to assist students who have the greatest financial need. The grant amount is based on financial need. The maximum can change each award year and depends on program funding.

10% INSTITUTIONAL GRANT

This grant is to assist students who are in the greatest financial need and are relocating or commuting 50 miles or greater to attend UTI by reducing their overall tuition.

GENERAL ELIGIBILITY CRITERIA

Relocating or commuting 50 or more miles daily to campus*

Have an EFC (Expected Family Contribution) of 11,000 or less

EXCLUSIONS

- Students receiving the Relocation Grant
- Students receiving the Salute to Service Grant
- Students receiving the 10% Technical Education Institutional Grant Program
- Students receiving any other UTI-funded, need-based scholarship, grant or tuition reduction
- Laptop, Lab Fee and Meter Fee coverage

RELOCATION GRANT

This grant is to assist students who are in the greatest financial need and are relocating or commuting 50 miles or greater to attend UTI by subsidizing costs associated with relocation, housing or making long commutes back and forth to school. The grant allows students to focus on academics and gaining local employment, helping set them up for long-term success.

GENERAL ELIGIBILITY CRITERIA

Relocating or commuting 50 or more miles daily to campus*

Have an EFC (Expected Family Contribution) of 11,000 or less

EXCLUSIONS

- Students receiving the Institutional Grant
- Students receiving the Salute to Service Grant
- Students receiving the 10% Technical Education Institutional Grant Program
- Students receiving any other UTI-funded, need-based scholarship, grant or tuition reduction

RELOCATION GRANT DISTRIBUTION OF FUNDS

Auto, Diesel, and Auto/Diesel programs: \$300 Laptop, \$195 Lab Fee, \$120 Meter Fee, \$500 Orientation Distribution, 1st and 2nd month rent support of \$899/month, 3rd, 4th and 5th month rent support of \$449/month, \$2,000 provided after successful completion of fifth (5th) course. **Total Grant Amount: \$6,260**

Laptop and meter are provided, and the dollar amounts cannot be exchanged for cash value or applied to tuition.

Rent payments will be provided within the last week of the month for the upcoming month's rent for non-shared housing students.
